

- CaseCheck Provides a list of cases that have cited your selected case.


Accessing the New Casemaker

Go to the Bar's homepage – www.scbar.org/.






Look on the left side of the page for the Member Login box:



Now just enter your Username and Password!

- Your Username is your Bar Number, but it has to be 7 digits!
- You must add enough leading zeroes in front to make the number 7 digits.
- For Example, if your Bar Number is 1234, you must add 3 leading zeroes, e.g.: 0001234.
- If you do not know your password, you can have your password emailed to the address on file with the Bar by clicking on Forgot Password under the Login Button.



- Now that you've logged in, you will see a Welcome message followed by your name.
- You can update your password if you'd like by clicking on Update My Password.
- Or you can simply click on Casemaker to be directly taken to the Casemaker page!



- Using the advanced search options below the search bar allows you to search by:
